BACKGROUND

1. This is an application by Magna Housing Group Limited ("Magna") to dispense with the requirement to consult lessees before entering into a long term agreement for the supply of energy. The application is dated 19th May 2014 and annexed to this decision is a schedule of the various properties affected by this decision.
2. Directions were issued on 21st May 2014 which provided for various matters including that this matter would be determined without an oral hearing unless any objection was received. No objection was received.

DECISION

3. The tribunal grants the application to dispense with consultation subject to the following conditions.
4. Magna must enter into the lowest price contract obtained following a tender process.
5. Within 42 days of entering into such a contract all affected leaseholders are notified of the same together with details of the basic terms and details as to how and when the contract may be inspected by any affected leaseholder.
6. In making this determination the tribunal reminds all affected parties that there has been no determination as to the reasonableness of any costs claimed or whether any costs are payable by any individual leaseholder.

THE LAW

7. The relevant law is set out in section 20ZA of the Landlord and Tenant Act 1985. A copy of the section is set out in the Annex to this decision.

DETERMINATION

8. The application provides that Magna intend to appoint external consultants Utilities Exchange Limited ("UX") to undertake a tender process to identify the lowest price available for a long term agreement for the supply of energy to Magna's portfolio of properties.
9. Magna explained that their current contracts for supply of energy expire on 30th September 2014 and they therefore need to approach the market to carry out a fresh procurement exercise.
10. Magna indicated that they intend to contract UX to undertake this exercise. UX are asked to tender for 12 and 24 month contracts to secure the best price possible in the market.

11. Magna explain that, as is well known, it is impractical to comply strictly with the requirements for consultation with the various long leaseholders affected. Magna submits that the prices regularly fluctuate and there is a benefit to undertaking this exercise in the Summer months whilst energy consumption is low and historically more advantageous prices are obtained.
12. Under the tribunal direction Magna were required to write to all affected leaseholders sending them a copy of the application and the directions. Any leaseholder who wished to oppose the application was then required to notify the tribunal.
13. Magna sought an extension of time for serving the application on all leaseholders until 11th June 2014 with the date for leaseholders objecting being revised until 25th June 2014. This was granted.
14. Magna subsequently confirmed to the tribunal that they had complied with the direction to notify all affected leaseholders and the tribunal had before it a sample letter demonstrating compliance dated 10th June 2014.
15. The tribunal received a letter from a I O'Hare on 17th June 2014 indicating he was taking advice on the application. No notice of objection was filed by him.
16. A Mr David Findlay copied to the tribunal a letter he had sent to Magna requesting further information and indicating he was aware of his need to file any objection by 25th June 2014. No objection was received.
17. No other correspondence was received from any other leaseholder and there were no objections to the application.
18. The tribunal accepts that the energy market in offering long term agreements require acceptance of offers within short timeframes far less than the time taken to comply with Section 20 of the Landlord & Tenant Act 1985 (as amended). Given Magna intend to utilise the services of an expert company, UX, to determine the best price the tribunal was satisfied that there was no prejudice to any of the long leaseholders. It was appropriate for dispensation from compliance with the requirements to be granted subject to conditions.
19. The tribunal determined that given Magna indicated that they will proceed with the best price it is reasonable to make this a condition of dispensation. Further to ensure all leaseholders are aware Magna must notify all leaseholders affected once a contract has been entered into and the basic terms of the same together with how the contract may be inspected if any party so wishes.

Appeals

1. A person wishing to appeal this decision to the Upper Tribunal (Lands Chamber) must seek permission to do so by making written application to the First-tier Tribunal at the Regional office which has been dealing with the case.
2. The application must arrive at the Tribunal within 28 days after the Tribunal sends to the person making the application written reasons for the decision.
3. If the person wishing to appeal does not comply with the 28-day time limit, the person shall include with the application for permission to appeal a request for an extension of time and the reason for not complying with the 28-day time limit; the Tribunal will then decide whether to extend time or not to allow the application for permission to appeal to proceed.
4. The application for permission to appeal must identify the decision of the Tribunal to which it relates, state the grounds of appeal, and state the result the party making the application is seeking.

ANNEX

Section 20ZA Landlord and Tenant Act 1985

Consultation requirements: supplementary

(1) Where an application is made to a leasehold valuation tribunal for a determination to dispense with all or any of the consultation requirements in relation to any qualifying works or qualifying long term agreement, the tribunal may make the determination if satisfied that it is reasonable to dispense with the requirements.

(2) In section 20 and this section—

- “qualifying works” means works on a building or any other premises, and
- “qualifying long term agreement” means (subject to subsection (3)) an agreement entered into, by or on behalf of the landlord or a superior landlord, for a term of more than twelve months.

(3) The Secretary of State may by regulations provide that an agreement is not a qualifying long term agreement—

- (a) if it is an agreement of a description prescribed by the regulations, or
- (b) in any circumstances so prescribed.

(4) In section 20 and this section “the consultation requirements” means requirements prescribed by regulations made by the Secretary of State.

(5) Regulations under subsection (4) may in particular include provision requiring the landlord—

- (a) to provide details of proposed works or agreements to tenants or the recognised tenants’ association representing them,
- (b) to obtain estimates for proposed works or agreements,
- (c) to invite tenants or the recognised tenants’ association to propose the names of persons from whom the landlord should try to obtain other estimates,
- (d) to have regard to observations made by tenants or the recognised tenants’ association in relation to proposed works or agreements and estimates, and

(e) to give reasons in prescribed circumstances for carrying out works or entering into agreements.

(6) Regulations under section 20 or this section—

(a) may make provision generally or only in relation to specific cases, and

(b) may make different provision for different purposes.

(7) Regulations under section 20 or this section shall be made by statutory instrument which shall be subject to annulment in pursuance of a resolution of either House of Parliament

ANNEX

Section 18 of the Landlord and Tenant Act 1985

Section 18 Meaning of "service charge" and "relevant costs".

(1) In the following provisions of this Act "service charge" means an amount payable by a tenant of a dwelling as part of or in addition to the rent—

(a) which is payable, directly or indirectly, for services, repairs, maintenance, improvements or insurance or the landlord's costs of management, and

(b) the whole or part of which varies or may vary according to the relevant costs.

(2) The relevant costs are the costs or estimated costs incurred or to be incurred by or on behalf of the landlord, or a superior landlord, in connection with the matters for which the service charge is payable.

(3) For this purpose—

(a) "costs" includes overheads, and

(b) costs are relevant costs in relation to a service charge whether they are incurred, or to be incurred, in the period for which the service charge is payable or in an earlier or later period
