I, EAMON RYAN, Minister for Communications, Marine and Natural Resources, in exercise of the powers conferred on me by section 1(2) of the National Oil Reserves Agency Act 2007 (No. 7 of 2007), hereby order as follows:

1. This Order may be cited as the National Oil Reserves Agency Act 2007 (Remaining Provisions) (Commencement) Order 2007.

2. The 1st day of August 2007 is appointed as the day on which the National Oil Reserves Agency Act 2007 (No. 7 of 2007), in so far as it is not already in operation, shall come into operation.
