**The Parking Places (Disabled Persons' Vehicles) (Amendment
No. 8) Order (Northern Ireland) 2011**

Made - - - - - *12th September 2011*

Coming into operation - - - - - *5th October 2011*

The Department for Regional Development(a) makes the following Order in exercise of the powers conferred by Articles 10(4), 13(1) and (16) of the Road Traffic Regulation (Northern Ireland) Order 1997(b) and now vested in it(c).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the roads specified in the Schedule.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a Notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as The Parking Places (Disabled Persons' Vehicles) (Amendment No. 8) Order (Northern Ireland) 2011 and shall come into operation on 5th October 2011.

Amendments

2. Schedule 1 to The Parking Places (Disabled Persons' Vehicles) Order (Northern Ireland) 2006(d) shall be amended by the addition of the items set out in the Schedule to this Order.

SCHEDULE

Article 2

Unlimited Waiting

- “734. Craighill, Ballycraigy, Antrim (south side) – from a point 70 metres east of its junction with Woodlawn, for a distance of 5 metres in an easterly direction.
- 735. Main Street, Ballykelly, (north side) – from a point 43 metres east of its junction with Dukes Lane, for a distance of 7.5 metres.
- 736. Kimona Drive, Belfast (south-west side) – from a point 65 metres south-east of its junction with Park Avenue, for a distance of 3.5 metres in a south-easterly direction.
- 737. Larkfield Park, Belfast (north-east side) – from a point 68 metres north-west of its junction with Palmerston Road, for a distance of 5.5 metres.
- 738. Marguerite Park, Belfast (north-east side) from a point 35 metres south-east of its junction with Diamond Gardens, for a distance of 6.6 metres.
- 739. St Jude’s Parade, Belfast (north side) – from a point 74 metres west of its junction with Ravenhill Road, for a distance of 5.5 metres.
- 740. Kinross Avenue, Dundonald (service road south side) – from a point 57.8 metres north-west of its junction with Kinross Avenue, (main road) for a distance of 3.6 metres in a westerly direction.
- 741. Cranfield Park, Larne (north side) – from a point 93 metres north-west of its junction with Linn Road, for a distance of 5 metres.
- 742. Main Street, Seskinore (north-west side) – from a point 23 metres north-east of its junction with Letfern Road, for a distance of 6.5 metres.”

The amendments provide for the introduction of parking places with unlimited waiting on the lengths of the road specified in the Schedule.
