**The Hanover Glen, Bangor (Abandonment) Order (Northern
Ireland) 2011**

Made - - - - *30th September 2011*

Coming into operation - *23rd November 2011*

The Department for Regional Development^(a) makes the following Order in exercise of the powers conferred by Article 68(1) and (5) of the Roads (Northern Ireland) Order 1993^(b) and now vested in it^(c).

The Department in accordance with Article 68(4) of that Order proposes on the completion of works providing alternative facilities for road traffic, to abandon the area of road described in the Schedule.

Notice has been published, served and displayed in compliance with paragraphs 1, 2 and 3 of Schedule 8 to that Order.

No objection has been received.

Citation, commencement and interpretation

1.—(1) This Order may be cited as The Hanover Glen, Bangor (Abandonment) Order (Northern Ireland) 2011 and shall come into operation on 23rd November 2011.

(2) In this Order “the developer” means James G. McAlorum Ltd whose registered office is situate at 5-7 Delamont Avenue, Bangor, BT20 4TZ.

Application

2. The developer shall carry out such works as the Department considers necessary for the provision of alternative facilities for road traffic and on completion of the works the area of road described in the Schedule shall be abandoned.

3.—(1) All existing cables, wires, mains, pipes or other apparatus placed along, across, over or under the abandoned area of road shall be retained.

(2) All existing rights as to the use or maintenance of such cables, wires, mains, pipes or other apparatus shall be preserved.
