**FAIR EMPLOYMENT**

**The Fair Employment (Specification of Public Authorities) (Amendment) Order (Northern Ireland) 2012**

*Made - - - - 7th March 2012*  
*Coming into operation 31st March 2012*

The Office of the First Minister and deputy First Minister(1) makes the following Order in exercise of the powers conferred by Articles 50 and 51 of the Fair Employment and Treatment (Northern Ireland) Order 1998(2) and now vested in it(3).

**Citation and commencement**

1. This Order may be cited as the Fair Employment (Specification of Public Authorities) (Amendment) Order (Northern Ireland) 2012 and shall come into operation on 31<sup>st</sup> March 2012.

**Amendment of the Fair Employment (Specification of Public Authorities) Order (Northern Ireland) 2004**

2. For the Schedule to the Fair Employment (Specification of Public Authorities) Order (Northern Ireland) 2004(4) substitute the Schedule set out in the Schedule to this Order.

**Revocations**

3. The Fair Employment (Specification of Public Authorities) (Amendment) Order (Northern Ireland) 2009(5) is hereby revoked.

## **EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order amends the Fair Employment (Specification of Public Authorities) Order (Northern Ireland) 2004 (“the 2004 Order”) which specifies a number of persons or bodies as public authorities for certain purposes under Part VII of the Fair Employment and Treatment (Northern Ireland) Order 1998 (“the 1998 Order”).

The Schedule to the 2004 Order lists in Part I the bodies who are public authorities for the purposes of Articles 52 to 65 of the 1998 Order and in Part II the bodies who are public authorities for the purposes of Articles 62 to 65 of the 1998 Order.

Article 2 of this Order substitutes a new Schedule to the 2004 Order.

The following bodies are added to Part I of the Schedule:

Charity Commission for Northern Ireland

Commissioner for Older People for Northern Ireland

Director of Public Prosecutions

Northern Ireland Courts and Tribunals Service

Police Rehabilitation and Retraining Trust

State Pathologist’s Department

The following body has been deleted from Part I of the Schedule:

The Economic Research Institute for Northern Ireland
