The Waiting Restrictions (Bushmills) (Amendment) Order (Northern Ireland) 2013

Made - - - - 21st November 2013

Coming into operation - 11th December 2013

The Department for Regional Development(\mathbf{a}) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997(\mathbf{b}) and now vested in it(\mathbf{c}).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as The Waiting Restrictions (Bushmills) (Amendment) Order (Northern Ireland) 2013 and shall come into operation on 11th December 2013.

Amendment

- **2.** The Waiting Restrictions (Bushmills) Order (Northern Ireland) 2012(**d**) shall be amended by the addition to the Schedule 1 of the following items —
- "3. Runkerry Road (U5026-2) (stretch of road leading to Runkerry house) (north-west side) from a point 100 metres north-west of its junction with Runkerry Road (U5026-1) (loop road) for a distance of 190 metres in a south-westerly direction.
- 4. Runkerry Road (U5026-2) (stretch of road leading to Runkerry house) (south-east side)

 from a point 100 metres north-west of its junction with Runkerry Road (U5026-1)
 (loop road) for a distance of 190 metres in a south-westerly direction."
