**The Parking Places (Disabled Persons' Vehicles) (Amendment
No. 2) Order (Northern Ireland) 2020**

Made - - - - - *17th November 2020*

Coming into operation - *8th December 2020*

The Department for Infrastructure^(a) makes the following Order in exercise of the powers conferred by Articles 10(4), 13(1) and (16) of, and paragraph 5 of Schedule 4 to, the Road Traffic Regulation (Northern Ireland) Order 1997^(b) and now vested in it^(c).

It appears to the Department to be necessary to provide suitable parking places for vehicles on the lengths of the roads specified in the Schedule.

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 4 to the Road Traffic Regulation (Northern Ireland) Order 1997.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

The Department in compliance with paragraph 3(4) of that Schedule, has taken such other steps as appear to the Department reasonably practicable for the purpose of bringing specifically to the knowledge of the occupiers of land adjacent to the parking places the particulars specified in paragraph 3(2) of that Schedule.

Six objections have been received and duly considered and no other representations have been received.

The Department has modified the draft Order.

Citation and commencement

1. This Order may be cited as The Parking Places (Disabled Persons' Vehicles) (Amendment No. 2) Order (Northern Ireland) 2020 and shall come into operation on 8th December 2020.

(3) Add the items set out in the Schedule to this Order.

“2782.	Donegore Drive, Antrim (west side) – from a point 19.5 metres north of its junction with Kilbride Gardens for a distance of 5.5 metres in a northerly direction.
2783.	Mallusk Gardens, Antrim (north-east side of a parking area in front of No. 5 Seacash Walk) – from a point 67 metres south-east of its junction with Seacash Drive for a distance of 5.5 metres in a north-easterly direction.
2784.	Riverside, Antrim (east side) – from a point 106 metres south of its junction with Riverside Mews for a distance of 5.5 metres in a southerly direction.
2785.	Maryville Park, Banbridge (north-west side in a lay-by) – from a point 35 metres south-west of its junction with Maryville Drive for a distance of 6 metres in a south-westerly direction.
2786.	Moorefield, Banbridge (south-west side – south-east side of a parking area) – from a point 40 metres north-west of its junction with Hill Street for a distance of 6 metres in a north-westerly direction.
2787.	Blackmountain Walk, Belfast (south side in a parking area to the rear of No. 14) – from a point 80 metres north-west of its junction with Blackmountain Way for a distance of 3 metres in a westerly direction.
2788.	Carrington Street, Belfast (south side) – from a point 94 metres west of its junction with Ravenhill Road for a distance of 5.5 metres in a westerly direction.
2789.	Drumart Drive, Belfast (north-east side in a parking area) – from a point 74 metres south-east of its junction with Archdale Park for a distance of 3 metres in a south-easterly direction.
2790.	Dundela Street, Belfast (north side) – from a point 140 metres west of its junction with Dundela Avenue for a distance of 5.5 metres in a westerly direction.
2791.	Highpark Drive, Belfast (east side) – from a point 59 metres north of its junction with Highpark Crescent for a distance of 10 metres in a northerly direction.
2792.	Larkfield Gardens, Belfast (north-east side) – from a point 90 metres south-east of its junction with Larkfield Drive for a distance of 5.5 metres in a south-easterly direction.
2793.	Northwood Road, Belfast (north-east side) – from a point 151 metres north-west of its junction with Northwood Crescent for a distance of 6 metres in a north-westerly direction.
2794.	Summerhill Avenue, Belfast (east side) – from a point 18 metres south of its junction with Cloghan Crescent for a distance of 6.6 metres in a southerly direction.
2795.	Sunnyside Drive, Belfast (north-west side) – from a point 50 metres south-west of its junction with Haywood Avenue for a distance of 5.5 metres in a south-westerly direction.
2796.	Willowbank Gardens, Belfast (north side) – from a point 75 metres west of its junction with Antrim Road for a distance of 5.5 metres in a westerly direction.
2797.	Victoria Gardens, Carrickfergus (west side in a parking area) – from a point 119.5 metres west of its junction with Victoria Road for a distance of 5.5 metres in a westerly direction.
2798.	Castleview, Gilford (south side in a lay-by in front of No. 56) – from a point 194 metres north of its junction with Castle Street for a distance of 6 metres in an easterly direction.
2799.	Moyard Gardens, Greenisland (south-west side in a parking area in front of No. 34) – from a point 205 metres south of its junction with Knockleigh Drive for a distance of 5.5 metres in a south-westerly direction.

2800.	Bay Road, Larne (north-west side) – from a point 31.5 metres south-west of its junction with Portland Street, for a distance of 5.5 metres in a south-westerly direction.
2801.	Station Road, Larne (south-west side) – from a point 84 metres north-west of its junction with Circular Road for a distance of 5.5 metres in a north-westerly direction.
2802.	Upper Cairncastle Road, Larne (west side in a lay-by in front of No. 5 Craigyhill Bungalows) – from a point 63 metres south-east of its junction with Greenway for a distance of 5.5 metres in a south-easterly direction.
2803.	Rushmore Park, Lisburn (south-west side – in a parking area) – from a point 23.5 metres south-east of its junction with Rushmore Drive for a distance of 3 metres in a south-easterly direction.
2804.	Riverview Terrace, Londonderry (south-east side) – from a point 15 metres north-east of its junction with Clifton Street for a distance of 6 metres in a north-easterly direction.
2805.	Forthill Gardens, Newtownabbey (south-west side in a parking area in front of No. 78) – from a point 197 metres south and then west of its western junction with Forthill Drive for a distance of 3 metres in an easterly direction.
2806.	Glenvarna Walk, Newtownabbey (east side in a parking area to the rear of No. 13 Glenvarna Drive) – from a point 22 metres north of its junction with Glenvarna Drive for a distance of 3 metres in a northerly direction.
2807.	Green End, Newtownabbey (north side – north side of a parking area in front of Block 11 A-H) – from a point 40 metres north of its junction with Rathmullan Drive for a distance of 5.5 metres in a northerly direction.
2808.	Inniscarn Drive, Newtownabbey (east side in a parking area) – from a point 50 metres north-east of its junction with Mournebeg Drive for a distance of 3 metres in a north-easterly direction.
2809.	Mountview Place, Newtownabbey (north side – north-west corner of a parking area in front of No. 14 Mountview Pass) – from a point 65 metres north-east of its junction with Woodland Drive for a distance of 5.5 metres in a north-westerly direction.
2810.	Parkmount Road, Newtownabbey (south-east side in a lay-by) – from a point 11 metres south-west of its junction with Parkmount Court for a distance of 5.5 metres in a south-westerly direction.”

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking Places (Disabled Persons' Vehicles) Order (Northern Ireland) 2016.

The amendments provide for the introduction of parking places with unlimited waiting on the lengths of the roads specified in the Schedule and the removal of the parking places referred to in Article 2(2).
