The Urban Clearways (Amendment No. 2) Order (Northern Ireland) 2021

Made - - - - - *22nd September 2021*

Coming into operation - *13th October 2021*

The Department for Infrastructure^(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997^(b) and now vested in it^(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No written objection or other representation has been received.

Citation and commencement

1. This Order may be cited as The Urban Clearways (Amendment No. 2) Order (Northern Ireland) 2021 and shall come into operation on 13th October 2021.

Amendments

2.—(1) Schedule 1 to The Urban Clearways Order (Northern Ireland) 2016^(d) is amended in accordance with paragraphs (2) and (3).

(2) Delete item no. 182 relating to Shore Road, Newtownabbey.

(3) After item no 194 add the following items—

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Urban Clearways Order (Northern Ireland) 2016 (“the Order”) by—

- (a) deleting the item relating to Shore Road, Newtownabbey; and
- (b) creating three lengths of urban clearway from Monday to Friday between the hours 8.00 a.m. to 9.30 a.m. and 3.00 p.m. to 6.30 p.m. in both directions on lengths of Shore Road, Greenisland/Newtownabbey.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of the Order will in due course be placed on the roads.
