**The Parking and Waiting Restrictions (Portadown)
(Amendment) Order (Northern Ireland) 2023**

Made - - - - *5th December 2023*

Coming into operation *28th December 2023*

The Department for Infrastructure^(a) makes the following Order in exercise of the powers conferred by Article 4(1), (2) and (3) of the Road Traffic Regulation (Northern Ireland) Order 1997^(b), and now vested in it^(c).

The Department has consulted such persons as it considered appropriate in compliance with paragraphs 1 and 2 of the Schedule 1 to that Order.

The Department has published a notice in compliance with paragraphs 1 and 3 of that Schedule.

No objection has been received.

Citation and Commencement

1. This Order may be cited as the Parking and Waiting Restrictions (Portadown) (Amendment) Order (Northern Ireland) 2023 and shall come into operation on 28th December 2023.

Amendment

2.—(1) The Parking and Waiting Restrictions (Portadown) Order (Northern Ireland) 2018^(d) is amended in accordance with paragraphs (2) and (3).

(2) In Article 1(2), for the definitions of “postal packet” and “universal service provider” substitute—

“postal packet” has the same meaning as in section 65(1) of the Postal Services Act 2011^(e);
and

“universal service provider” has the same meaning as in section 65(1) of the Postal Services Act 2011.

(3) In Part 1 of Schedule 2 after item 25 add the following item—

(a) Formerly the Department for Regional Development; see section 1(6) and (11) of, and Schedule 1 to, the Departments Act (Northern Ireland) 2016 (2016 c. 5 (N.I.))
(b) S.I. 1997/276 (N.I. 2)

(e) 2011 c. 5

“26. Obins Street (south-west side) – from its junction with Woodhouse Street for a distance of 30 metres in a north-westerly direction.”

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends The Parking and Waiting Restrictions (Portadown) Order (Northern Ireland) 2018 (“the Order”) by the addition to Part 1 of Schedule 2 of the item relating to Obins Street as specified in Article 2(3), and updates the definitions of “postal packet” and “universal service provider”.

A penalty charge (£90) is payable with respect to a vehicle involved in a contravention of the Order in accordance with the Traffic Management (Northern Ireland) Order 2005 and The Penalty Charges (Prescribed Amounts) Regulations (Northern Ireland) 2006.

Traffic signs indicating the effect of this Order will in due course be placed on the road.
