**The Pollution Prevention and Control Act 1999  
(Commencement No. 4 and Amendment) (Scotland) Order 2015**

The Scottish Ministers make the following Order in exercise of the powers conferred by section 7(3) of the Pollution Prevention and Control Act 1999<sup>(1)</sup> and all other powers enabling them to do so.

**Citation and commencement**

1.—(1) This Order may be cited as the Pollution Prevention and Control Act 1999 (Commencement No. 4 and Amendment) (Scotland) Order 2015.

(2) This article and article 2 come into force on 31st March 2015.

(3) Article 3 comes into force on 1st April 2015.

**Amendment to the Pollution Prevention and Control Act 1999 (Commencement No. 3)  
(Scotland) Order 2015**

2.—(1) The Pollution Prevention and Control Act 1999 (Commencement No. 3) (Scotland) Order 2015<sup>(2)</sup> is amended as follows.

(2) In article 2(2), omit sub-paragraphs (h) to (l).

### **Appointed day**

**3.** 1st April 2015 is the day appointed for the coming into force of section 6(2) of, and Schedule 3 to, the Pollution Prevention and Control Act 1999 so far as relating to the following repeals in the Environment Act 1995**(3)**—

- (a) section 111(6);
- (b) section 113(5), in the definition of “local enforcing authority”, paragraph (d) and the “or” preceding it;
- (c) in section 114(2)(a)(iii), “15, 22(5),”;
- (d) in paragraph 4(3)(b) of Schedule 20, “22(5),”; and
- (e) paragraphs 45 to 61 of Schedule 22.

## EXPLANATORY NOTE

*(This note is not part of the Order)*

This Order corrects an error in the Pollution Prevention and Control Act 1999 (Commencement No. 3) (Scotland) Order 2015 before that Order comes into force. Article 3 ensures that certain repeals to the Environment Act 1995 made by Schedule 3 to the Pollution Prevention and Control Act 1999 are clearly commenced on 1st April 2015.
