**ROAD TRAFFIC**

**The M77/A77 Trunk Road (Bankfield Roundabout) (Temporary  
40mph Speed Restriction) Order 2016**

*Made* - - - - *24th August 2016*

*Coming into force* - - *2nd September 2016*

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1) and 14(1)(b) and (4) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with section 14(1)(b) of that Act, they are satisfied that the traffic on the length of road specified in the schedule should be restricted because of the likelihood of danger to the public, or of serious damage to the road, which is not attributable to works.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

**Citation, commencement and cessation**

1. This Order may be cited as the M77/A77 Trunk Road (Bankfield Roundabout) (Temporary 40mph Speed Restriction) Order 2016, comes into force on 2nd September 2016 and ceases to have effect on 4th September 2016.

**Speed restriction**

2. No person may use, or permit the use of, any vehicle on the length of road, or a part or parts of a length of road, specified in the schedule of this Order at a speed exceeding 40 miles per hour when a restriction is identified as applying to that length of road, or a part or parts of that length of road, by means of a traffic sign prescribed in Diagram 670 of the Traffic Signs Regulations and General Directions 2016(b).

### **Exemption**

3. No speed restriction imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011<sup>(a)</sup> when used in accordance with regulation 3(5) of those Regulations.

## SCHEDULE

Article 2

### SPECIFIED LENGTH OF ROAD

1. That length of the M77/A77 Glasgow – Stranraer Trunk Road from its junction on the southside of Bankfield roundabout to the B7034 Carcluie Toll, a distance of 3.7 kilometres or thereby.
