**ROAD TRAFFIC**

**The A78 Trunk Road (Open Golf Championship, Dundonald)  
(Temporary 40mph Speed Restriction) Order 2017**

*Made* - - - - - *29th June 2017*

*Coming into force* - - - - - *11th July 2017*

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1), 4(1) and 14(1)(b) and (4) of the Road Traffic Regulation Act 1984<sup>(a)</sup> and all other powers enabling them to do so.

In accordance with section 14(1)(b) of that Act, they are satisfied that the traffic on the length of road specified in the schedule should be restricted because of the likelihood of danger to the public, or of serious damage to the road, which is not attributable to works.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

**Citation, commencement and cessation**

1. This Order may be cited as the A78 Trunk Road (Open Golf Championship, Dundonald) (Temporary 40mph Speed Restriction) Order 2017, comes into force on 11th July 2017 and ceases to have effect on 18th July 2017.

**Speed restriction**

2. No person may use, or permit the use of, any vehicle on the length of road, or a part or parts of a length of road, specified in the schedule of this Order at a speed exceeding 40 miles per hour when a restriction is identified as applying to that length of road, or a part or parts of that length of road, by means of a traffic sign of the type described in item 1 (diagram 670 – maximum speed limit in mph) of the sign table in Part 2 of schedule 10 of the Traffic Signs Regulations and General Directions 2016<sup>(b)</sup>.

### **Exemption**

**3.** No speed restriction imposed by this Order applies to—

- (a) vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011<sup>(a)</sup> when used in accordance with regulation 3(5) of those Regulations; or
- (b) vehicles being used in an emergency for coastguard purposes.

## SCHEDULE

Article 2

### SPECIFIED LENGTH OF ROAD

That length of the A78 Greenock – Prestwick Trunk Road, near Irvine, from a point 298 metres or thereby south of the commencement of the off slip to the A759 North to a point 335 metres or thereby south of the commencement of the off slip to the A71, a distance of 4.3 kilometres or thereby.
