ROAD TRAFFIC

**The M8/A8 Trunk Road (Craigton to St James Interchange)
(Temporary Vehicle Width Restriction) Order 2019**

Made - - - - *15th May 2019*

Coming into force - - *22nd May 2019*

The Scottish Ministers make the following Order in exercise of the powers conferred by sections 2(1) and (2), 4(1), and 14(1)(a) and (4) of the Road Traffic Regulation Act 1984^(a) and all other powers enabling them to do so.

In accordance with section 14(1)(a) of that Act, they are satisfied that the traffic on the length of road specified in the schedule should be restricted or prohibited because works are being or are proposed to be executed on or near that length of road.

In accordance with section 14(3) of that Act, they have had regard to the existence of alternative routes suitable for the traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the M8/A8 Trunk Road (Craigton to St James Interchange) (Temporary Vehicle Width Restriction) Order 2019, comes into force on 22 May 2019 and ceases to have effect on 31 October 2019.

Width Restriction

2. No person may use, or permit the use of, any vehicle on the length of road specified in the schedule if the width of the vehicle exceeds 2 metres when such restriction is identified as applying to any part or parts of that length of road by means of a traffic sign as prescribed in item 14 (diagram 7243 – temporary road layout with lane restrictions) of Part 6 of schedule 13 of the Traffic Signs Regulations and General Directions 2016^(b).

The Scottish Ministers are the traffic authority by virtue of section 121A of the Road Traffic Regulation Act 1984 (inserted by the 1991 Act, schedule 8, paragraph 70 and amended by S.I. 2001/1400) as read with section 151(1) of the Roads (Scotland) Act 1984 (c.54) (relevantly amended by S.I. 2001/1400). The functions of the Secretary of State were transferred to the Scottish Ministers by section 53 of the Scotland Act 1998 (c.46).

Exemptions

3. No prohibition imposed by this Order applies to—

- (a) a vehicle while being used in an emergency for fire brigade, coastguard, ambulance or police purposes; or
- (b) a vehicle being used for carrying out the works.

SCHEDULE

Article 2

SPECIFIED LENGTH OF ROAD

That length of the M8/A8 Edinburgh – Greenock Trunk Road being the westbound carriageway from a point 2.2 kilometres or thereby west of junction 29 (St James Interchange) on ramp to the off ramp at junction 30 (Craigton), a distance of 2.5 kilometres or thereby.

That length of the M8/A8 Edinburgh – Greenock Trunk Road being the eastbound from the off slip of junction 30 (Craigton) to a point 2.2 kilometres or thereby west of junction 29 (St James Interchange) off ramp, a distance of 2.5 kilometres or thereby.
