JUDGMENT

Employment Tribunals Rules of Procedure 2013 – Rules 21 and 60

Upon the respondent not presenting a response to claim number 2402202/21 and upon the basis of admissions in the response to claim number 2419915/20, judgment is as follows:

1. The respondent has made an unauthorised deduction from the claimant's wages by not paying wages to the claimant (at the rate of 80% of normal pay) in the period 1 September 2020 to 11 November 2020 inclusive and is ordered to pay the claimant the gross sum of £3,124.77.
2. The respondent was in breach of contract by not paying the claimant (at the rate of 100% of normal pay) during his 10 weeks' notice period and the respondent is ordered to pay damages to the claimant in the sum of £3,829.80. This is a net sum but is based on the claimant's gross pay because it is likely that upon receipt the claimant will have to pay tax on this amount.
3. The claimant was dismissed by reason of redundancy and is entitled to a redundancy payment of £5,744.70.
4. The respondent has made an unauthorised deduction from the claimant's wages by failing to pay the claimant in lieu of accrued but untaken holiday entitlement and is ordered to pay the claimant the gross sum of £1,149.

5. The complaints about deduction of employee pension contributions and underpayment for holiday taken during furlough will be the subject of a further judgment on paper or will be determined at a final hearing, if it appears there is a time limit or any other outstanding issue to be decided.

THE EMPLOYMENT TRIBUNALS (INTEREST) ORDER 1990

Name of case(s): **Mr J McGrath** v **Lunar Automotive Ltd**

The Employment Tribunals (Interest) Order 1990 provides that sums of money payable as a result of a judgment of an Employment Tribunal (excluding sums representing costs or expenses), shall carry interest where the full amount is not paid within 14 days after the day that the document containing the tribunal's written judgment is recorded as having been sent to parties. That day is known as "*the relevant decision day*". The date from which interest starts to accrue is called "*the calculation day*" and is the day immediately following the relevant decision day.
