

# Freedom of Information Act 2000 (FOIA) Decision notice

Date: 25 September 2017

Public Authority: Ministry of Justice Address: 102 Petty France

## Decision (including any steps ordered)

- 1. The complainant has requested information from the Ministry of Justice (MoJ) regarding G4S contracts to run youth detention centres.
- 2. The Commissioner's decision is that the MoJ has breached section 10(1) of the FOIA as it has failed to give a substantive response to this request.
- 3. The Commissioner requires the public authority to take the following steps to ensure compliance with the legislation.
  - The MoJ must issue a response to the request in accordance with its obligations under the FOIA.
- 4. The public authority must take these steps within 35 calendar days of the date of this decision notice. Failure to comply may result in the Commissioner making written certification of this fact to the High Court pursuant to section 54 of the Act and may be dealt with as a contempt of court.

## Request and response

5. On 24 May 2017, the complainant wrote to the MoJ and requested information in the following terms:

"This is a Freedom of Information Act request.

1) Please provide the date on which G4S's contract to run Medway secure training centre was terminated.



- 2) Please provide the contract value (in GBP) paid to G4S for the delivery of youth detention accommodation at Medway secure training centre for 2015/16 and 2016/17.
- 3) Please provide the contract value (in GBP) paid/to be paid for G4S for the delivery of youth detention accommodation at Oakhill secure training centre for the 2015/16, 2016/17 and the current financial year.
- 4) Please provide the date of the final payment made/to be made to G4S in respect of its contract for the delivery of youth detention accommodation at Medway secure training centre, and the period for which the payment relates.
- 5) Please state how long the Ministry of Justice anticipates Her Majesty's Prison and Probation Service running Medway secure training centre.
- 6) If an external provider continues to be sought to run Medway secure training centre, please describe G4S's role (if any) in the awarding of this contract.
- 7) Please provide a copy of the G4S Improvement Plan for Medway secure training centre, which included the organisation's analysis of what went wrong with organisational culture at Medway to enable staff to feel they could act as they did towards children and how they propose to address this."
- 6. The MoJ did not respond to the request.

### Scope of the case

- 7. The complainant contacted the Commissioner on 6 July 2017 to complain about the way her request for information had been handled.
- 8. Following receipt of the complaint the Commissioner contacted the MoJ, reminding it of its responsibilities and asking it to respond to the complainant within 10 working days.
- 9. Despite this intervention the MoJ has failed to respond to the complainant.

#### Reasons for decision

10. Section 10(1) of FOIA states that

"Subject to subsections (2) and (3), a public authority must comply with section 1(1) promptly and in any event not later than the twentieth working day following the date of receipt."



11. As a response has not yet been provided the Commissioner finds that the MoJ has breached section 10(1) in failing to respond within 20 working days.



## Right of appeal

12. Either party has the right to appeal against this decision notice to the First-tier Tribunal (Information Rights). Information about the appeals process may be obtained from:
