**ROAD TRAFFIC**

**The A11 Trunk Road (Six Mile Bottom) and the A14 Trunk Road (North of Junction 36, Bottisham) Various Lay-bys, Cambridgeshire (Temporary Prohibition of Traffic) Order 2010**

*Made* - - - -

*1 November 2010*

*Coming into force* - -

*8 November 2010*

WHEREAS the Secretary of State for Transport, being the traffic authority for the A11 Trunk Road (“the A11”) and the A14 Trunk Road (“the A14”), is satisfied that traffic on those roads in the County of Cambridgeshire should be prohibited because works are proposed to be executed thereon:

NOW THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984<sup>(a)</sup> hereby makes the following Order:

1. This Order may be cited as the A11 Trunk Road (Six Mile Bottom) and the A14 Trunk Road (North of Junction 36, Bottisham) Various Lay-bys, Cambridgeshire (Temporary Prohibition of Traffic) Order 2010 and shall come into force on 8 November 2010.

2. In this Order -

“lay-by” means an area of carriageway, intended for the waiting of vehicles, bounded partly by a road marking on the outer edge of that carriageway complying with diagram 1010 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002<sup>(b)</sup>; and in this definition “carriageway” means a way constituting or comprised in a trunk road (other than a cycle track) over which the public have a right of way for the passage of vehicles and which has a surface suitable for the exercise of that right;

“works” mean drainage improvement works;

“the works period” means the period starting at 20:00 hours on Monday 15 November 2010 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 4 no person shall, during the works period, cause or permit any vehicle to enter the lay-by adjacent to the –

- (a) A11 northbound carriageway situated 170 metres north of Brinkley Road Underbridge, and
- (b) A14 westbound carriageway situated –

---

- (i) 1900 metres, and
  - (ii) 900 metres
- east of Swaffham Heath Road overbridge.

4. The provisions of article 3 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs and shall not apply to a vehicle being used for, or in connection with the said works or for police, fire and rescue authority, ambulance or traffic officer purposes.
