ROAD TRAFFIC

The A46 Trunk Road (M69 Junction, North of Coventry) (50 Miles Per Hour Speed Limit) Order 2011

Made - - - - 13th May 2011
Coming into force - - 27th May 2011

The Secretary of State for Transport in exercise of the powers conferred by section 84(1)(a) and (2) and 122A of, and paragraph 27(1) of Schedule 9 to, the Road Traffic Regulation Act 1984(a); and of all other powers enabling him in that behalf, hereby makes the following Order:

1. This Order may be cited as the A46 Trunk Road (M69 Junction, North of Coventry) (50 Miles Per Hour Speed Limit) Order 2011 and shall come into force on 27th May 2011.

2. No person shall cause or permit any vehicle to be driven at a speed exceeding 50 miles per hour on –

- a) the eastbound carriageway of the A46 Trunk Road from a point 20 metres south of its roundabout junction with the A4600 and the slip roads leading to and from the M6 at Junction 2, to a point 720 metres southeast of that roundabout.
- b) the westbound carriageway of the A46 Trunk Road from a point 720 metres southeast of its roundabout junction with the A4600 and the slip roads leading to and from the M6 at Junction 2, to its junction with that roundabout;
- c) a length of the link road leading from the northbound carriageway of the A46 to the westbound and eastbound carriageways of the A46, from a point 295 metres north of its nosing with the northbound carriageway to its junctions with the westbound and eastbound carriageways.
- d) a length of the link road leading from the eastbound carriageway of the A46 to the southbound carriageway of the A46, from its nosing with the eastbound carriageway to a point 100 metres south of that nosing, and
- e) a length of the link road leading from the westbound carriageway of Ansty Park Link Road to its junction with the link road leading from the eastbound carriageway of the A46, from a point 70 metres west of its nosing with Ansty Park Link Road to its junction with the link road leading from the eastbound carriageway of the A46.

3. Any previous order under the Road Traffic Regulation Act 1984 or any enactment replaced by that Act which provided that the A46 Trunk Road or any part thereof should cease to be a restricted road is amended by excluding any reference to the lengths of the trunk road or the connecting roads described in article 2 of this Order.
