**The Olympic Route Network Designation (Amendment) Order
2011**

The Olympic Delivery Authority, with the consent of the Secretary of State for Transport, makes the following Order in exercise of the power conferred by section 11(2) of the London Olympic Games and Paralympic Games Act 2006(a).

In accordance with section 11(4)(a) of that Act, the Olympic Delivery Authority has consulted the relevant authorities referred to in that section.

Citation and commencement

1. This Order may be cited as the Olympic Route Network Designation (Amendment) Order 2011 and comes into force on 8th August 2011.

Amendment of Order

- 2.—(1) The Olympic Route Network Designation Order 2009(b) is amended as follows.
- (2) In the Schedule (roads designated as roads in the Olympic Route Network)—
- (a) Part 1 is amended in accordance with Schedule 1 to this Order; and
 - (b) Part 2 is amended in accordance with Schedule 2 to this Order.

SCHEDULE 1

Article 2(2)(a)

AMENDMENTS TO PART 1 (numbered roads)

1. In paragraph 7—
 - (a) at the end of sub-paragraph (b), omit “and”; and
 - (b) at the end of sub-paragraph (c), insert—

“; and
 - (d) its junction with Marlborough Road in the City of Westminster to its junction with Whitehall (A3212)”.

“25. A106 from its junction with Kenton Road (B113) to its junction with Temple Mills Lane in the London Borough of Waltham Forest.”

“26. A107 from its junction with Graham Road (A1207) to its junction with Morning Lane (B113).”
10. For paragraph 29 substitute—

“29. A117 from its intersection with A1020 at Gallions roundabout to and including Woolwich Ferry Pier (A117).”
11. In paragraph 31 for “Monarch’s Way (A1010)” substitute “Great Cambridge Road (A10)”.
12. For paragraph 32 substitute—

“32. A123 from—

 - (a) the roundabout at its intersection with Eastern Avenue (A12) to the roundabout at its junction with Forest Road in the London Borough of Redbridge; and
 - (b) its junction with Upney Lane in the London Borough of Barking and Dagenham to its junction with Ripple Road (A13).”

13. Omit paragraph 35.

14. In paragraph 37 after “Deptford Church Street (A2209)” insert “including that part of Queen Elizabeth Street in the London Borough of Southwark between its junction with Tooley Street (A200) and Tower Bridge Road (A100)”.

15. In paragraph 42 for “Blackhall” substitute “Blackwall”.

16. For paragraph 43 substitute—

“43. A207 from—

- (a) the Sun-in-the-Sands roundabout (A2) to its intersection with Academy Road (A205); and
- (b) its junction with Bourne Road (A223) to the junction of Crayford Road (A207) including the one-way system at that junction consisting of parts of those roads and the whole of Roman Way (A207).”

17. In paragraph 46 for “Somerset Road” substitute “Calonne Road”.

18. After paragraph 46 insert—

“46A. A220 from the roundabout south of East Rochester Way (A2) to the roundabout north of East Rochester Way (A2).

46B. A223 from its junction with East Rochester Way (A2) to its junction with London Road (A207).

46C. A226 from its junction with Crayford Road (A207) to its junction with Maiden Lane at the boundary of the London Borough of Bexley and the District of Dartford in the County of Kent.”

21. In paragraph 59 after “Victoria Square (A354)” insert “, including, from such time as the Weymouth Relief Road is opened to traffic, the Weymouth Relief Road and the roads previously comprising the A354 except for that part of Dorchester Road north of its junction with the Weymouth Relief Road”.

22. In paragraph 62 for “Chiswick High Road (A315)” substitute “Holland Road (A3220)”.

23. For paragraph 66 substitute—

“66. A1010 from its junction with Bromley Road in the London Borough of Haringey to its intersection with Angel Road (A406).”

24. Omit paragraph 70.

25. After paragraph 74 insert—

“74A. A1205 from its junction with Bow Road (A11) to its junction with Commercial Road (A13).”

26. For paragraph 75 substitute—

“75. A1206 from—

- (a) its junction with East India Dock Road (A13) to its junction with Aspen Way (A1261), being Cotton Street; and
- (b) its junction with West India Dock Road (A1261) to its junction with the slip roads to the Limehouse Link Tunnel (A1203), including the slip roads.”

27. In paragraph 79 for “Limehouse Link (A1203)” substitute “Commercial Road (A13)”.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order, which is made by the Olympic Delivery Authority (“the ODA”) with the consent of the Secretary of State for Transport, amends the Olympic Route Network Designation Order 2009 (“the 2009 Order”). The amendments make additions and changes (including the removal of certain roads) to the list of roads set out in the 2009 Order which constitute the Olympic Route Network.
