**ROAD TRAFFIC**

**The A14 Trunk Road (Felixstowe Dock No.1 Roundabout,  
Suffolk) (Prohibition of Waiting) Order 2011**

*Made* - - - - - 6 January 2011

*Coming into force* - - - - - 20 January 2011

The Secretary of State for Transport makes the following Order in exercise of the powers conferred by sections 1(1), 2(1) and (2) of the Road Traffic Regulation Act 1984(a):

**1.** This Order may be cited as the A14 Trunk Road (Felixstowe Dock No.1 Roundabout, Suffolk) (Prohibition of Waiting) Order 2011 and shall come into force on 20 January 2011.

**2.** Save as provided in article 3 below no person shall, except upon the direction of, or with the permission of, a constable or a traffic officer in uniform, cause or permit any vehicle to wait at any time on any day on a side of the trunk road as specified in the Schedule to this Order.

**3.** Nothing in article 2 above shall apply –

(a) so as to prevent a vehicle waiting on any part of the trunk road, for so long as may be necessary to enable that vehicle to be used in connection with –

(i) any building operation or demolition,

(ii) the removal of any obstruction to traffic,

(iii) the maintenance, improvement or reconstruction of the trunk road, or

(iv) the laying, erection, inspection, maintenance, alteration, repair, renewal or removal in or near the trunk road of any sewer, main, pipe, conduit, wire, cable or other apparatus for the supply of gas, water, electricity or of any telecommunications apparatus as defined in Schedule 2 of the Telecommunications Act 1984(b),

(b) in relation to a vehicle being used –

(i) for fire brigade, ambulance or police purposes, or

(ii) in the service of a local authority or of a water authority in pursuance of their respective statutory powers, and

- (c) in relation to a vehicle waiting when the person in control of it is –
- (i) required by law to stop,
  - (ii) obliged to stop in order to avoid an accident, or
  - (iii) prevented from proceeding by circumstances outside their control.

## SCHEDULE

Article 3

### **Sides of the A14 Trunk Road in Felixstowe in the County of Suffolk on which waiting is prohibited at all times, with exceptions:**

The circulatory carriageway of the A14 Trunk Road at Felixstowe Dock No.1 Roundabout (Walton Avenue) -

1. From the junction with the eastbound carriageway Port of Felixstowe Road to its junction with Haven Exchange a distance of 28 metres.
2. From the junction with Haven Exchange to its junction with the eastbound carriageway of Walton Avenue (A14 East) a distance of 15 metres.
3. From the junction with Walton Avenue (east) eastbound carriageway south side to its junction with Walton Avenue (east) westbound carriageway north side a distance of 17 metres.
4. From the junction with Walton Avenue (east) westbound carriageway south side to the junction with Dock Road southbound carriageway north side a distance of 13 metres.
5. From the junction with Dock Road northbound carriageway to the junction with Walton Avenue (A14 West) westbound carriageway a distance of 25 metres.
6. From the junction with A14 Port of Felixstowe Road westbound carriageway north side to the junction of A14 Port of Felixstowe Road eastbound carriageway south side a distance of 26 metres.
7. From the junction with Walton Avenue A14 (West) eastbound carriageway to the junction with A14 Port of Felixstowe Road westbound carriageway a distance of 17 metres.

The approaches to the A14 Trunk Road at Felixstowe Dock No.1 Roundabout (Walton Avenue) -

8. From the junction with A14 Walton Avenue (west) eastbound carriageway north side northwards for a distance of 4 metres.
9. From the junction with Haven Exchange (north side) westwards for a distance of 15 metres.
10. From the junction with A14 Walton Avenue (east) eastbound carriageway north side southeastwards for a distance of 72 metres.
11. From the junction with A14 Walton Avenue (east) eastbound carriageway south side southeastwards for a distance of 58 metres.
12. From the junction with A14 Walton Avenue (west) westbound carriageway south side westwards for a distance of 7 metres.

13. From the junction of A14 Port of Felixstowe Road westbound carriageway north side for a distance of 4 metres.
14. From the junction with Haven Exchange (south side) southwards for a distance of 10 metres.
15. From the junction with Dock Road (southbound) northwards for a distance of 6 metres.

**EXPLANATORY NOTE**  
(This note is not part of the Order)

This Order will prohibit waiting at any time on the carriageway of the A14 Felixstowe Dock No. 1 (Walton Avenue) Roundabout.
