**ROAD TRAFFIC**

**The A616 Trunk Road (Deepcar Junction, Stockbridge)  
(Temporary Restriction and Prohibition of Traffic) Order 2011**

*Made* - - - - *7th March 2011*

*Coming into force* - - *20th March 2011*

WHEREAS the Secretary of State for Transport, being the traffic authority for the A616 Trunk Road and connecting roads, in the District of Sheffield, in the County of South Yorkshire, is satisfied that traffic on that trunk road and some of those connecting roads should be restricted and prohibited because road marking renewal works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), makes the following Order:-

**1.** This Order may be cited as the A616 Trunk Road (Deepcar Junction, Stockbridge) (Temporary Restriction and Prohibition of Traffic) Order 2011 and shall come into force on 20th March 2011.

**2.** In this Order; –

“the A616” means the A616 Trunk Road from a point 70 metres west of the centreline of the A616 overbridge at the A6102 Deepcar Interchange eastwards for a distance of 180 metres;

“a slip road” means the A616 Trunk Road eastbound and westbound entry and exit slip roads at Deepcar Interchange;

“the works period” means a period of 10 hours starting at 20:00 hours on Monday 21st March 2011 or any subsequent night thereafter until the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

**3.** Subject as mentioned in article 6, no person shall, during the works period, cause or permit any vehicle to be driven in the A616 at a speed exceeding:

- (a) 10 miles per hour whilst traffic signs of a character authorised under Section 64 of the Road Traffic Regulation Act 1984 indicating “convoy working” on those carriageways are displayed; or
- (b) 40 miles per hour whilst such traffic signs in relation to those carriageways are not displayed.

**4.** Subject as mentioned in article 6, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the A616 or a slip road.

**5.** Subject as mentioned in article 6, no person shall, during the works period, cause or permit any vehicle to overtake another moving vehicle in the A616.

6. The provisions of articles 3, 4 and 5 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs. Nothing in articles 4 and 5 shall apply to:

- (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
- (b) a vehicle being used for or in connection with the said works, or for winter maintenance or traffic officer purposes; or
- (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform;

and nothing in article 3 shall apply to any vehicle being used for a purpose specified in paragraph (a) of this article.
