**The Immigration (Designation of Travel Bans) (Amendment)
Order 2012**

<i>Coming into force</i> - -	<i>3rd July 2012</i>

The Secretary of State makes the following Order in exercise of the power conferred by section 8B(5) of the Immigration Act 1971(a).

1. This Order may be cited as the Immigration (Designation of Travel Bans) (Amendment) Order 2012 and shall come into force on 3rd July 2012.

2. For the Schedule to the Immigration (Designation of Travel Bans) Order 2000(b) substitute the Schedule set out in Schedule 1 to this Order.

3. The instruments listed in Schedule 2 to this Order are revoked.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the Immigration (Designation of Travel Bans) Order 2000 (the “2000 Order”) by substituting a new Schedule into the 2000 Order. Any person named by or under an instrument listed in the new Schedule or falling within a description in such an instrument will be excluded from the United Kingdom (subject to the exceptions specified in Article 3 of the 2000 Order).

The effect of substituting the Schedule is to add to and delete from the list of designated instruments.
