**ROAD TRAFFIC**

**The A5 Trunk Road (Lutterworth, Leicestershire) (Temporary  
Restriction and Prohibition of Traffic) Order 2013**

*Made* - - - - 21st June 2013

*Coming into force* - - 28th June 2013

WHEREAS the Secretary of State for Transport, being the traffic authority for the A5 Trunk Road (“the A5”), is satisfied that traffic on lengths of that road near Lutterworth, in the Counties of Leicestershire and Warwickshire, should be restricted and prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1) (a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as A5 Trunk Road (Lutterworth, Leicestershire) (Temporary Restriction and Prohibition of Traffic) Order 2013 and shall come into force on 28th June 2013.

2. In this Order –

“Magna Park Roundabout” means the circulatory carriageway of the A5 at its roundabout junction with the A4303, B4027 and Coal Pit Lane;

“the first length of trunk road” means the northbound and southbound carriageways of the A5 between a point 250 metres north and a point 250 metres south of Magna Park Roundabout;

“the second length of trunk road” means -

- i) the northbound and southbound carriageways of the A5 between a point 1370 metres north and a point 645 metres south of Magna Park Roundabout; and
- ii) the northbound carriageway of the A5 between a point 1250 metres south and a point 645 metres south of Magna Park Roundabout;

---

(a) 1984 c.27; a new section 14 was substituted by the Road Traffic (Temporary Restrictions) Act 1991 (c.26), section 1(1) and Schedule 1

---

- “the third length of trunk road” means –
- i) the northbound carriageway of the A5 between a point 2545 metres south and a point 1250 metres south of Magna Park Roundabout; and
  - ii) the southbound carriageway of the A5 between a point 2370 metres north and a point 1370 metres north of Magna Park Roundabout;
- "the works period" means the period starting at 20:00 hours on Monday 1st July 2013 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

**3.** Subject as mentioned in articles 5 and 6, no person shall, during the works period, drive any motor vehicle at a speed exceeding –

- (a) 50 miles per hour on the third length of trunk road;
- (b) 40 miles per hour on the second length of trunk road; or
- (b) 10 miles per hour on lengths of the first length of trunk road whilst traffic signs of a character authorised under section 64 of the Road Traffic Regulation Act 1984 indicating “convoy working” on those lengths of road are displayed.

**4.** Subject as mentioned in articles 5 and 6, no person shall, during the works period, cause or permit any vehicle to enter or proceed in Magna Park Roundabout.

**5.** The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs.

**6.** The provisions of:

- (a) articles 3 and 4 shall not apply to any vehicle -
  - (i) being used for police, fire brigade or ambulance purposes, or
  - (ii) proceeding at the direction of, or with the permission of, a police constable;
- (b) article 3 shall not apply to any vehicle being used for special forces purposes; and
- (c) article 4 shall not apply to any vehicle being used in connection with the said works.
