ROAD TRAFFIC

**The M5 Motorway and A46 Trunk Road (Ashchurch,
Gloucestershire) (Temporary Prohibition of Traffic) Order 2014**

Made - - - - *10th March 2014*
Coming into force - - *17th March 2014*

WHEREAS the Secretary of State for Transport, being the traffic authority for the M5 Motorway (“the M5”), A46 Trunk Road (“the A46”) and connecting roads, is satisfied that traffic on a length of one of those roads and some of those connecting roads, at Ashchurch in the County of Gloucestershire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order: -

1. This Order may be cited as the M5 Motorway and A46 Trunk Road (Ashchurch, Gloucestershire) (Temporary Prohibition of Traffic) Order 2014 and shall come into force on Monday 17th March 2014.

2. In this Order:

“the trunk road” means the eastbound and westbound carriageways of the A46 from its junction with the A438 Ashchurch Road and M5 roundabout (M5 Junction 9) and its junction with Northway Lane;

“a slip road” means the slip roads leading –

- (i) to the northbound carriageway of the M5 at Junction 9; and
- (ii) from the southbound carriageway of the M5 at Junction 9;

“the works period” means the period starting at 00:01 hours on Monday 24th March 2014 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 5, no person shall, during the works period, cause or permit any vehicle to enter or proceed in the trunk road or a slip road.

4. Subject as mentioned in article 5, no person shall, during the works period, cause or permit any vehicle to enter or leave -

- i) the trunk road at its junction with any side road; or
- ii) the westbound carriageway of the A46 at its junction with the B4079.

5. The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle -

- (a) being used for police, fire brigade or ambulance purposes;
- (b) proceeding at the direction of, or with the permission of, a police constable in uniform;
- (c) being used for or in connection with the said works; or
- (d) proceeding to and from premises which are accessible from, and only from, the trunk road.
