**The A36 Trunk Road (South Newton, Near Salisbury)
(Temporary Restriction of Traffic) (No.2) Order 2015**

Made - - - - *3rd March 2015*

Coming into force - - *7th March 2015*

WHEREAS the Secretary of State for Transport, being the traffic authority for the A36 Trunk Road (“the A36”), is satisfied that traffic on lengths of that road near South Newton in Wiltshire should be restricted because works are proposed to be executed nearby:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:

1. This Order may be cited as the A36 Trunk Road (South Newton, Near Salisbury) (Temporary Restriction of Traffic) (No.2) Order 2015 and shall come into force on 7th March 2015.

2. In this Order –

“the first length of the A36” means the A36 near South Newton from a point 40 metres south east of its junction with 1 Redbrick Cottages to a point 50 metres southeast of its junction with Chilhampton Farm;

“the second length of the A36” means the A36 near South Newton from a point 50 metres south east of its junction with Chilhampton Farm to a point 120 metres northwest of its junction with Plough Cottage;

“the works” mean works to construct a water pipeline adjacent to the A36 requiring a temporary HGV access;

“the works period” means the period starting at 08.00 hours on Monday 9th March 2015 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to an article in this Order which bears that number.

3. Subject as mentioned in articles 5 and 6, no person shall, during the works period, drive any motor vehicle at a speed exceeding 30 miles per hour on the first length of the A36.

4. Subject as mentioned in articles 5 and 6, no person shall, during the works period, drive any motor vehicle at a speed exceeding 40 miles per hour on the second length of the A36.

5. The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to:

(a) a vehicle being used for police, fire and rescue authority or ambulance purposes; or

(a) 1984 c.27; a new section 14 was substituted by the Road Traffic (Temporary Restrictions) Act 1991 (c.26), section 1(1) and Schedule 1.

(b) anything done at the direction of, or with the permission of, a constable.

6. No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
