ROAD TRAFFIC

The M5 Motorway (Junctions 18-17) (Temporary Restriction and Prohibition of Traffic) Order 2015

Made - - - - 10th March 2015

Coming into force - - 13th March 2015

WHEREAS the Secretary of State for Transport, being the traffic authority for the M5 Motorway ("the M5") and connecting roads, is satisfied that traffic on lengths of that road between Junctions 18 and 17 in the City of Bristol and in South Gloucestershire should be restricted and prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a) and regulation 16(2) of the Motorways Traffic (England and Wales) Regulations 1982(b), hereby makes the following Order:

1. This Order may be cited as the M5 Motorway (Junctions 18-17) (Temporary Restriction and Prohibition of Traffic) Order 2015 and shall come into force on 13th March 2015.

2. In this Order -

"the first length of the M5" means the northbound and southbound carriageways from a point at the centre of the Lawrence Weston Road overbridge to a point at the centre of the Berwick Lodge Access overbridge;

"the second length of the M5" means (i) the northbound carriageway of the M5 between the tip of the nosing of the northbound exit slip road at Junction 18 and the tip of the nosing of the northbound entry slip road at Junction 17; and (ii) the southbound carriageway of the M5 between the tip of the nosing of the southbound exit slip road at Junction 17 and the tip of the nosing of the southbound entry slip road at Junction 18;

"the Regulations" means the Motorways Traffic (England and Wales) Regulations 1982;

"the hard shoulder" means the hard shoulder within the meaning of regulation 3(1)(e) of the Regulations which is adjacent to the M5;

"the works" means the resurfacing of the main carriageway, road marking, studs and improvement works to include drainage;

" a first works period"; means a period of 16 hours starting at 06.00 hours on Monday 16th March 2015 or on any subsequent day and ending when the said works have been completed;

"a second works period" means a period of 8 hours starting at 22.00 hours on Monday 16th March 2015 or on any subsequent day and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to an article in this Order which bears that number.

- **3.** Subject as mentioned in articles 5 and 7, no person shall, during a first works period:
 - (a) drive any motor vehicle at a speed exceeding 50 miles per hour on the first length of the M5:
 - (b) cause or permit any vehicle with an overall width exceeding 2.5 metres to enter or proceed in any lane other than the left hand or middle lane of the first length of the M5;
 - (c) cause or permit any vehicle with an overall width exceeding 3 metres to enter or proceed in any lane other than the left hand lane of the first length of the M5.
- **4.** Subject as mentioned in articles 5 and 6, no person shall, during a second works period, cause or permit any vehicle to enter or proceed in the second length of the M5.
- **5.** The provisions of articles 3 and 4 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to:
 - (a) a vehicle being used for police, fire and rescue authority or ambulance purposes; or
 - (b) anything done at the direction of, or with the permission of, a constable.
- **6**. The provisions of article 4 shall not apply to a vehicle being used in connection with the works, for traffic officer purposes or for winter maintenance purposes.
- 7. No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations.
- **8.** During a works period, regulation 5 and (insofar as it relates to a vehicle being driven) regulation 9 of the Regulations are hereby suspended, in respect of the hard shoulder, at such times and to such extent as shall from time to time be indicated by traffic signs.
