**ROAD TRAFFIC**

**The M18 Motorway and A1(M) Motorway (Wadworth)  
(Temporary Prohibition of Traffic) Order 2015**

*Made* - - - - 22nd January 2015

*Coming into force* - - 1st February 2015

WHEREAS, the Secretary of State for Transport, being the traffic authority for the M18 Motorway, the A1(M) Motorway and connecting roads, in the Districts of Doncaster and Rotherham, in the County of South Yorkshire, is satisfied that traffic on those motorways and some of those connecting roads should be prohibited because carriageway resurfacing, traffic loop renewal and road marking works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), makes the following Order:

**1.** This Order may be cited as the M18 Motorway and the A1(M) Motorway (Wadworth) (Temporary Prohibition of Traffic) Order 2015 and shall come into force on 1st February 2015.

**2.** In this Order:

“the M18” means the M18 Motorway at Junction 2 (Wadworth);

“the A1(M)” means the A1(M) Motorway at Junction 35 (Wadworth);

“the roundabout” means the circulatory carriageway of the A1(M)/M18 Wadworth Interchange Roundabout;

“a slip road” means any of the following slip roads:

(i) M18 southbound and northbound exit slip roads at Junction 2; or

(ii) A1(M) southbound exit and entry slip roads at Junction 35;

“the works period” means a period of 10 hours starting at 20:00 hours on Monday 2nd February 2015 or any subsequent night thereafter until the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

**3.** Subject as mentioned in article 4 no person shall, during the works period, cause or permit any vehicle to enter or proceed in the roundabout or a slip road.

**4.** The provisions of article 3 shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs and shall not apply to:

(a) a vehicle being used for police, fire and rescue authority or ambulance purposes;

- (b) a vehicle being used for, or in connection with, the said works, or for winter maintenance or traffic officer purposes; or
- (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform;
