**The Air Navigation (Restriction of Flying) (East Kirkby)
Regulations 2016**

Made - - - - *24th May 2016*

Coming into force - - *6th August 2016*

The Secretary of State has decided that it is necessary in the public interest to restrict flying in the vicinity of East Kirkby, Lincolnshire by reason of the holding of the East Kirkby Air Show on 6th August 2016.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 161 of the Air Navigation Order 2009(a).

Citation and commencement

1. These Regulations may be cited as the Air Navigation (Restriction of Flying) (East Kirkby) Regulations 2016 and come into force on 6th August 2016.

Interpretation

2. In regulation 3(1) the times referred to are Co-ordinated Universal Time(b).

Restricted airspace

3.—(1) Subject to paragraph (2), between 0900 hours and 1600 hours on 6th August 2016 no aircraft is to fly below 2,000 feet above mean sea level within the area bounded by a circle having a radius of 1.5 nautical miles whose centre is at 530811N 0000019E.

(2) Paragraph (1) does not apply to any aircraft—

- (a) flying with the permission of the East Kirkby Air Show flying display director, or
- (b) making an approach to, or departure from, RAF Coningsby in accordance with a clearance issued by the air traffic control unit at RAF Coningsby.

(b) In these Regulations Co-ordinated Universal Time (UTC) is one hour behind British Summer Time (BST).

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations impose restrictions on flying in airspace specified in regulation 3(1) in the vicinity of East Kirkby, Lincolnshire during the East Kirkby Air Show that is scheduled to take place there on 6th August 2016. A large number of aircraft will be involved in high energy manoeuvres during the display and therefore the Civil Aviation Authority and the Department for Transport agree that flying should be restricted in the vicinity of the displays for reasons of public safety.

In relation to regulation 3, the term 'aircraft' includes aircraft as classified by Part A of Schedule 3 to the Air Navigation Order 2009. It also includes, by virtue of article 253(3) of that Order, any small balloon, any kite weighing not more than two kilograms, any small unmanned aircraft and any parachute including a parascending parachute.

The times mentioned in regulation 3(1) are Universal Co-ordinated Time (UTC), which for the purpose of these Regulations is one hour behind British Summer Time.

Full details of the Statutory Instrument will be promulgated by Aeronautical Information Circular and NOTAM.
