**The M6 Toll Motorway (M6 Junction 11a to Junction T7)
(Staffordshire) (Temporary Prohibition of Traffic) (No. 2)
Order 2017**

Made 17th July 2017

Coming into force 24th July 2017

WHEREAS the Secretary of State for Transport, being the traffic authority for the M6 Toll Motorway (“the M6 Toll”) and connecting roads, is satisfied that traffic on lengths of that motorway and one of those connecting roads, in the County of Staffordshire, should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State for Transport, in exercise of the powers conferred by section 14(1)(a) of and paragraph 27(1) of schedule 9 to, the Road Traffic Regulation Act 1984(a) and regulation 16(2) of the Motorways Traffic (England and Wales) Regulations 1982(b), hereby makes the following Order:-

1. This Order may be cited as The M6 Toll Motorway (M6 Junction 11a to Junction T7) (Staffordshire) (Temporary Prohibition of Traffic) (No. 2) Order 2017 and shall come into force on Monday 24th July 2017.

2. In this Order –

“the first length of Motorway”	means the southbound carriageway of the M6 Toll from its junction with the M6 at Junction 11a, to its junction with the entry slip road at Junction T7;
“the second length of motorway”	means the southbound carriageway of the M6 Toll from a point 120 metres northwest of the centreline of Great Saredon Road overbridge, to a point 350 metres east of the centreline of the B4154 Walsall Road overbridge, at Norton Canes;
“the slip road”	means the slip road leading to the southbound carriageway of the M6 Toll at Junction T8;
“the regulations”	means the Motorways Traffic (England and Wales) Regulations 1982;

“a hard shoulder”	means the hard shoulder, within the meaning of regulation 3(1) (e) of the regulations, which is adjacent to the second length of motorway;
"the works period"	means the period starting at 00:01 hours on Monday 24th July 2017 and ending when the said works have been completed;

and a reference to an article followed by a number is a reference to the article in this Order which bears that number.

3. Subject as mentioned in article 4, no person shall, during the works period, cause or permit any vehicle to enter or proceed on the first length of motorway or the slip road.

4. The provisions of article 3 shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs and shall not apply to any vehicle –

- a) being used for police, fire brigade or ambulance purposes;
- b) proceeding at the direction of, or with the permission of, a police constable;
- c) being used in connection with the said works; or
- d) being driven by, or at the direction of, a traffic officer in uniform.

5. During the works period, regulations 5 and (in so far as it relates to a vehicle being driven) 9 of the regulations, in respect of a hard shoulder, are hereby suspended at such times and to such extent as may be indicated by traffic signs.

6. The M6 Toll Motorway (Junction 11a to Junction T7) (Staffordshire) (Temporary Prohibition of Traffic) Order 2017 (a) is hereby revoked.
