Sir,

I have the honour to refer to the British Expatriates Supplementation (Botswana) Agreement 1976⁽¹⁾, as amended⁽²⁾ (hereinafter referred to as "the agreement") and to propose that the agreement be further amended by deleting in sub-paragraph (3) of paragraph 1 the words and figures "31 March 1981" and substituting therefor the words and figures "31 March 1986"; and by deleting the following from the list of employing authorities in the second annex to the agreement:

Botswana Agricultural Marketing Board.
Water Utilities Corporation.
Botswana Housing Corporation.
Botswana Development Corporation.
Brigades Skill Development Centre.
Bank of Botswana.
Botswana Livestock Development Corporation.
Institute of Development Management.

If this proposal is acceptable to the Government of Botswana, I have the honour to suggest that this note and your reply shall constitute an agreement between our two governments which shall enter into force on 31 March 1981 and which shall be cited, together with the agreement, as the British Expatriates Supplementation (Botswana) Agreement 1976/81.
