ON BEHALF OF THE UNITED KINGDOM OF GREAT BRITAIN AND
NORTHERN IRELAND, AND THE GOVERNMENT OF THE FEDERAL
REPUBLIC OF YUGOSLAVIA REVIVING THE AGREEMENT ON AIR
SERVICES SIGNED AT LONDON ON 3 FEBRUARY 1959, AS AMENDED**

The Embassy of the Federative Republic of Brazil in Belgrade presents its compliments to the Federal Ministry of Foreign Affairs of the Federal Republic of Yugoslavia and, on behalf of the British Interests Section, has the honour to propose that the Agreement concerning Air Services signed in London on 3 February 1959¹, as amended,² be brought back into force.³

If this proposal is acceptable to the Government of the Federal Republic of Yugoslavia, the British Interests Section of the Embassy of the Federative Republic of Brazil has the honour to propose that this Note, and the federal Ministry's reply to that effect, shall constitute an Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Federal Republic of Yugoslavia which shall enter into force on the date of the Federal Ministry's reply.

The Embassy of the Federative Republic of Brazil avails itself of this opportunity to renew to the Federal Ministry of Foreign Affairs of the Federal Republic of Yugoslavia the assurances of its highest consideration.
