ROAD TRAFFIC, WALES

The A55 Trunk Road (Junction 35, Dobs Hill, Flintshire, Eastbound Carriageway and Eastbound Off Slip Road) (Temporary Prohibitions and 40 MPH Speed Limit) Order 2011.

Made 2 March 2011

Coming into force 7 March 2011

The Welsh Ministers, being the traffic authority for the relevant lengths of the Chester to Bangor Trunk Road (A55) (hereinafter referred to as the “trunk road”), are satisfied that traffic in specified lengths of the trunk road should be prohibited and restricted by reason of works proposed to be executed thereon.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

1. This Order shall come into force on 7 March 2011. Its title is The A55 Trunk Road (Junction 35, Dobs Hill, Flintshire, Eastbound Carriageway and Eastbound Off Slip Road) (Temporary Prohibitions and 40 MPH Speed Limit) Order 2011.

2. (1) In this Order:

“works period” (“*cyfnod y gwaith*”) means that period commencing at 00:01 hours on 7 March 2011 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article or Schedule is a reference to the article or Schedule bearing that number in this Order.

3. Subject to the provisions of article 6, no person shall, during the works period, drive any vehicle or cause or permit any vehicle to proceed in the length of the trunk road described in Schedule 1.

4. Subject to the provisions of article 6, no person shall, during the works period, ride or cause to be ridden, any pedal cycles in the length of the trunk road described in Schedule 1.

5. Subject to the provisions of article 6, no person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour in the length of the trunk road described in Schedule 2.

6. The provisions of article 3, 4 and 5 shall apply only during such times and to such extent as the application of the prohibition and restriction referred to therein is indicated by traffic signs.

7. The maximum duration for this Order shall be 6 months.

SCHEDULE 1

Temporary Prohibition of Vehicles and Cyclists

The entire length of the eastbound off slip road of the A55 Trunk Road at Junction 35, Dobshill in the County of Flintshire.

SCHEDULE 2

Temporary 40 MPH Speed Limit

That length of the main eastbound carriageway of the A55 Trunk Road in the County of Flintshire which extends westwards from the centre-point of Junction 35, Dobs Hill for a distance of 2500 metres.
