

**2012 No. 2221 (W. 248)**

**ROAD TRAFFIC, WALES**

**The A40 Trunk Road (Tarrell  
Roundabout, Brecon to County  
Boundary, Glangrwyney, Powys)  
(Temporary Traffic Restrictions and  
Prohibition) Order 2012**

*Made* 24 August 2012

*Coming into force* 4 September 2012

The Welsh Ministers, being the traffic authority for the relevant length of the Raglan to Llandoverly Trunk Road (A40) (hereinafter referred to as “the trunk road”), are satisfied that traffic in specified lengths of the trunk road should be restricted and prohibited by reason of works proposed to be executed thereon.

The Welsh Ministers, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

**Title, Interpretation and Commencement**

1.—(1) This Order comes into force on 4 September 2012. The title to this Order is The A40 Trunk Road (Tarrell Roundabout, Brecon to County Boundary, Glangrwyney, Powys) (Temporary Traffic Restrictions and Prohibition) Order 2012.

(2) In this Order:

“lengths of the trunk road” (“darnau o'r gefnffordd”) means those lengths of the trunk road

in the County of Powys as described in the Schedule to this Order;

“exempted vehicle” (“*cerbyd esempt*”) means any vehicle being used for emergency services or for, or in connection with, the works giving rise to this Order;

“works period,” (“*cyfnod y gwaith*”) means that period commencing at 08.00 hours on 4 September 2012 and ending when the temporary traffic signs are permanently removed.

(3) Any reference in this Order to a numbered article or Schedule is a reference to the article or Schedule bearing that number in this Order.

### **Prohibitions and Restriction**

2.—(1) Subject to the provisions of article 7, no person shall, during the works period, ride, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed at a speed exceeding 40 miles per hour in the lengths of the trunk road.

(2) Subject to the provisions of article 7, no person shall, during the works period, ride, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed at a speed exceeding 30 miles per hour in the lengths of the trunk road.

(3) Subject to the provisions of article 7, no person shall, during the works period, ride, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed at a speed exceeding 10 miles per hour in the lengths of the trunk road.

(4) Subject to the provisions of article 7, no person shall, during the works period, use or permit the use of a vehicle, other than an exempted vehicle, in such a way that it overtakes any other vehicle in the lengths of the trunk road, during such times as the restriction referred to in article 5 is in operation.

### **Application**

3. The provisions of articles 3, 4, 5 and 6 shall apply only during such times and to such extent as the application of the restriction and prohibition referred to therein is indicated by traffic signs.

**Duration of this Order**

4. The maximum duration for this Order shall be 12 months.

## SCHEDULE

### Lengths of the A40 Trunk Road between Tarrell Roundabout, Brecon and the County Boundary, Glangrwyney, in Powys.

- (i) The length of the A40 Trunk Road that extends in a westerly direction from the centre point of its junction with the A479 Trunk Road at Glan Usk Park to a point 780m north of the centre point of its junction with the B4560 at Pantybeili, South of Bwlch.
  
- (ii) The length of the A40 Trunk Road that extends in a north westerly direction from the centre point of its junction with the U0350 at Llansantffraed, Talybont-on-Usk (Powys) to the B4558 westbound 'on-slip' road at Cefn Brynich, Brecon.
