# ROAD TRAFFIC, WALES

The A494 Trunk Road (Pwll-glâs, Denbighshire) (Temporary Traffic Prohibitions and Restrictions) Order 2014

Made 18 November 2014

Coming into force 24 November 2014

The Welsh Ministers, being the traffic authority for the relevant length of the Dolgellau – South of Birkenhead Trunk Road (A494) ("the trunk road"), are satisfied that traffic in a specified length of the trunk road should be prohibited or restricted because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

### **Title, Interpretation and Commencement**

**1.** This Order comes into force on 24 November 2014. Its title is The A494 Trunk Road (Pwll-glâs, Denbighshire) (Temporary Traffic Prohibitions and Restrictions) Order 2014.

#### **2.**—(1) In this Order:

"exempted vehicle" ("cerbyd esempt") means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

"the length of the trunk road" ("y darn o'r gefnffordd") means that length of the A494 trunk road at Pwll-glâs in the County of Denbighshire which extends from a point 230 metres north of its junction with the unclassified road leading to Efenechtyd to a point 200 metres south of the property known as Minffordd, south of Pwll-glâs;

"works period" ("cyfnod y gwaith") means intermittent periods commencing at 07:30 hours on 24 November 2014 and ending when the temporary traffic signs for each period of works are removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

#### **Prohibitions and Restrictions**

- **3.** Subject to the provisions of article 7, no person shall, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed in the length of the trunk road.
- **4.** Subject to the provisions of article 7, no person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour in the length of the trunk road.
- **5.** Subject to the provisions of article 7, no person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour in the length of the trunk road.
- **6.** Subject to the provisions of article 7, no person shall, during the works period, use or permit the use of any vehicle, other than an exempted vehicle, in such a way that it overtakes any other vehicle in the length of the trunk road during such times as the restriction referred to in article 5 is in operation.

#### **Application**

**7.** The provisions of articles 3, 4, 5 and 6 apply only during such times and to such extent as the application of the prohibitions and restrictions referred to therein are indicated by traffic signs.

#### **Duration of this Order**

**8.** The maximum duration of this Order shall be 12 months.
