**The A55 Trunk Road (Junction 2
(Ty Mawr Interchange), Isle of
Anglesey) (Temporary Prohibition
of Vehicles) Order 2016**

Made 1 June 2016

Coming into force 6 June 2016

The Welsh Ministers, being the traffic authority for the relevant length of the London – Holyhead Trunk Road (A55) (“the trunk road”), are satisfied that traffic in specified lengths of the trunk road should be prohibited because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1), (4) and (7) of the Road Traffic Regulation Act 1984(1) and of all other enabling powers(2), make this Order.

Title, Interpretation and Commencement

1. This Order comes into force on 6 June 2016 and its title is The A55 Trunk Road (Junction 2 (Ty Mawr Interchange), Isle of Anglesey) (Temporary Prohibition of Vehicles) Order 2016.

2. —(1) In this Order:

“the lengths of the trunk road” (“*y darnau o’r gefnffordd*”) means those lengths of the trunk road on the Isle of Anglesey specified in the Schedules to this Order;

“works period” (“*cyfnod y gwaith*”) means the period commencing at 10:00 hours on 6 June 2016 and ending when the temporary traffic signs are permanently removed.

(2) Any reference in this Order to a numbered article or Schedule is a reference to the article or Schedule bearing that number in this Order.

Prohibitions

3. Subject to the provisions of article 7 no person shall, during the works period, drive or cause or permit any vehicle to be driven in either the eastbound or westbound carriageway of the length of the trunk road specified in Schedule 1.

4. (1) Whilst movement of traffic is by article 3 prohibited in the eastbound carriageway but, pursuant to article 7, not prohibited in the westbound carriageway, no person shall drive, cause or permit any vehicle to proceed in the offside lane of the westbound carriageway of the trunk road in any direction other than eastwards.

(2) Whilst movement of traffic is by article 3 prohibited in the westbound carriageway but, pursuant to article 7, not prohibited in the eastbound carriageway, no person shall drive, cause or permit any vehicle to proceed in the offside lane of the eastbound carriageway of the trunk road in any direction other than westwards.

5. Subject to the provisions of article 7 no person shall, during the works period, drive or cause or permit any vehicle to be driven in the lengths of the trunk road specified in Schedule 2.

Suspensions

6. The provisions of The A55 Trunk Road (Holyhead, Anglesey) (50 mph Speed Limit & Prohibition of Pedestrians) Order 2001(3) are suspended insofar as they apply to the length of the trunk road specified in Schedule 1 during such times as the prohibitions specified in articles 3 and 4 are in operation and the provisions of The A55 Trunk Road (Lay-bys between Junction 2 (Trearddur Bay) & Junction 8 (Llanfair PG), Isle of Anglesey) (Restriction of Waiting) Order 2016(4) are also suspended during the works period.

Application

7. The provisions of articles 3, 4 and 5 apply only during such times and to such extent as the application of the prohibitions referred to therein is indicated by traffic signs.

Duration of this Order

8. The maximum duration for this Order shall be 12 months.

SCHEDULE 1 Contraflow

The length of the trunk road that extends from a point 557 metres west of the centre-point of Junction 2 (Ty Mawr Interchange) to a point 4.894 kilometres east of the centre-point of the said junction.

SCHEDULE 2 Temporary Prohibition of Vehicles

The entire lengths of the eastbound and westbound exit and entry slip roads at Junction 2 (Ty Mawr Interchange).
