**The A487 Trunk Road (Y Felinheli
Bypass, Gwynedd) (Temporary
Traffic Prohibitions & Restrictions)
Order 2017**

Made 28 November 2017

Coming into force 4 December 2017

The Welsh Ministers, being the traffic authority for the Fishguard to Bangor Trunk Road (A487), are satisfied that traffic on a specified length of the trunk road should be prohibited and/or restricted because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1), (4) and (7) of the Road Traffic Regulation Act 1984(1), make this Order.

Title, Interpretation and Commencement

1. This Order comes into force on 4 December 2017 and its title is The A487 Trunk Road (Y Felinheli Bypass, Gwynedd) (Temporary Traffic Prohibitions & Restrictions) Order 2017.

2.—(1) In this Order:

“exempted vehicle” (“*cerbyd esempt*”) means:

- (a) any vehicle being used by the emergency services or in connection with the works giving rise to this Order; and
- (b) any vehicle being used for naval, military or air force purposes and being driven by a

person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the special forces—

- (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or
- (ii) for the purpose of training a person in driving vehicles at high speeds;

“special forces” (“*lluoedd arbennig*”) means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director;

“the trunk road” (“*y gefnffordd*”) means the Fishguard to Bangor trunk road (A487), Y Felinheli Bypass in the County of Gwynedd that extends from its junction with the north-eastern side of Plas Menai Roundabout to its junction with the southern side of Faenol Roundabout;

“works period” (“*cyfnod y gwaith*”) means intermittent periods commencing at 08:00 hours on 4 December 2017 and ending when the temporary traffic signs for each period of works are removed.

(2) Any reference in this Order to a numbered article is a reference to the article bearing that number in this Order.

Prohibitions and Restrictions

3. No person shall, during the works period, drive or cause or permit any vehicle, other than an exempted vehicle, to proceed on either the northbound or southbound carriageway of the length of the trunk road.

4. No person shall, during the works period, ride or cause to be ridden, any pedal cycle on the length of the trunk road.

5. No person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 40 miles per hour on the length of the trunk road.

6. No person shall, during the works period, drive or cause or permit any vehicle to proceed at a speed exceeding 10 miles per hour on the length of the trunk road.

7. No person shall, during the works period, use or permit the use of a vehicle in such a way that it overtakes any other vehicle on the length of the trunk

road specified in article 2 during such times as the restriction referred to in article 6 is in operation.

Suspension

8. Any statutory provisions restricting the speed of vehicles on the length of the trunk road are suspended during such times as the restrictions specified in articles 5 and 6 are in operation.

Application

9.—(1) The prohibitions and restrictions in articles 3, 4, 5, 6 and 7 apply only during such times and to such extent as indicated by traffic signs.

(2) No speed limits imposed by this Order apply to an exempted vehicle.

Duration of this Order

10. The maximum duration of this Order shall be 18 months.
