**ROAD TRAFFIC, WALES**

**The A487 Trunk Road (Great  
Darkgate Street & Owain Glyndwr  
Square, Aberystwyth, Ceredigion)  
(Temporary Prohibition of Vehicles)  
Order 2021**

*Made* 26 November 2021

*Coming into force* 4 December 2021

The Welsh Ministers, as traffic authority for the A487 trunk road, are satisfied that traffic on a specified length of the trunk road should be prohibited by reason of a relevant event, namely the Lantern Parade and Christmas Lights switch-on, being held on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 16A of the Road Traffic Regulation Act 1984(1), make this Order.

**Title and commencement**

1. The title of this Order is the A487 Trunk Road (Great Darkgate Street & Owain Glyndwr Square, Aberystwyth, Ceredigion) (Temporary Prohibition of Vehicles) Order 2021 and this Order comes into force on 4 December 2021.

**Interpretation**

2. In this Order—

“exempted vehicle” (“*cerbyd esempt*”) means:

- (a) any vehicle being used for police, fire or ambulance services purposes;
- (b) any vehicle being used in connection with works to the road or lighting or traffic signs or emergency works to any sewer or to any main

or apparatus for the supply of gas, water or electricity, or telecommunications in, or in any land adjacent to, a length of road concerned;

(c) any vehicle used by an authorised event official in support of and for reasons of the safety of the relevant event;

“event period” (“*cyfnod y digwyddiad*”) means that period commencing at 16:00 hours on 4 December 2021 and ending when the temporary traffic signs are permanently removed;

“the trunk road” (“*y gefnffordd*”) means the A487 Fishguard to Bangor trunk road.

### **Prohibition**

3. No person may, during the event period, drive any vehicle, other than an exempted vehicle, on the length of the trunk road known as Great Darkgate Street and Owain Glyndwr Square at Aberystwyth, Ceredigion that extends from its junction with Bridge Street and Pier Street to its junction with Terrace Road.

### **Application**

4. The prohibition in article 3 applies only during such times and to such extent as indicated by traffic signs.

### **Duration of this Order**

5. The maximum duration of this Order is 1 day.
