The A449 & A40 Trunk Roads
(Coldra Interchange, Newport to the
Wales/England Border,
Monmouthshire) (Temporary
Traffic Prohibitions & Restrictions)
Order 2021

Made 28 May 2021

Coming into force 3 June 2021

The Welsh Ministers, as traffic authority for the relevant lengths of the A449 and A40 trunk roads, are satisfied that traffic on specified lengths of the trunk roads should be prohibited and/or restricted because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1), (4) and (7) of the Road Traffic Regulation Act 1984⁽¹⁾, make this Order.

Title and commencement

1. The title of this Order is the A449 & A40 Trunk Roads (Coldra Interchange, Newport to the Wales/England Border, Monmouthshire) (Temporary Traffic Prohibitions & Restrictions) Order 2021 and this Order comes into force on 3 June 2021.

Interpretation

2. In this Order—

“exempted vehicle” (“*cerbyd esempt*”) means:

- (a) any vehicle being used for the purposes described in section 87 of the Road Traffic Regulation Act 1984(1); and
- (b) any vehicle being used for naval, military or air force purposes and being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the special forces—
 - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or
 - (ii) for the purpose of training a person in driving vehicles at high speeds;

“special forces” (“*lluoedd arbennig*”) means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director;

“the trunk roads” (“*y cefnffyrdd*”) means the A449 and A40 Newport to Worcester trunk roads;

“works period” (“*cyfnod y gwaith*”) means intermittent periods commencing at 20:00 hours on 3 June 2021 and ending when the temporary traffic signs for each period of works are removed.

Prohibitions and restrictions

3. No person may, during the works period, drive any vehicle, other than an exempted vehicle, on the lengths of the trunk road specified in Schedule 1 to this Order.

4. No person may, during the works period, drive any motor vehicle at a speed exceeding 50 miles per hour on the length of the trunk roads specified in Schedule 2 to this Order.

5. No person may, during the works period, drive any motor vehicle at a speed exceeding 40 miles per hour on the length of the trunk roads specified in Schedule 2 to this Order.

6. No person may, during the works period, drive any motor vehicle at a speed exceeding 10 miles per

hour on the length of the trunk roads specified in Schedule 2 to this Order.

7. No person may, during the works period, use or permit the use of a vehicle, other than an exempted vehicle, in such a way that it overtakes any other vehicle on the length of the trunk roads specified in Schedule 2 to this Order during such times as the restriction in article 6 is in operation.

Application

8.—(1) The prohibitions and restrictions in articles 3, 4, 5, 6 and 7 apply only during such times and to such extent as indicated by traffic signs.

(2) No speed limits imposed by this Order apply to an exempted vehicle.

Suspension

9. Any statutory provisions restricting the speed of vehicles on the length of the trunk road specified in Schedule 2 to this Order are suspended during such times as the restrictions specified in articles 4, 5 and 6 are in operation.

Duration of this Order

10. The maximum duration of this Order is 18 months.

SCHEDULE 1

Temporary prohibition of vehicles

The length of the A449 trunk road that extends from its junction with the circulatory carriageway of Coldra Interchange, Newport (Junction 24) to the centre-point of the A449 and A40 Raglan Interchange, Monmouthshire.

The lengths of the A449 northbound and southbound exit and entry slip roads at Usk Interchange, Monmouthshire.

The lengths of the A449/A40 northbound and southbound exit and entry slip roads at Raglan Interchange, Monmouthshire.

SCHEDULE 2

**Temporary 50 mph, 40 mph or 10 mph speed limits
& no overtaking**

The length of the A449 and A40 trunk roads that extends from its junction with the circulatory carriageway of Coldra Interchange, Newport (M4 Junction 24) to the centre-point of Chapel Lane over-bridge, north of Monmouth.
