**The A483 Trunk Road (Llandovery
to Sugar Loaf, Carmarthenshire)
(Temporary Traffic Prohibitions &
Restrictions) Order 2023**

Made 9 June 2023

Coming into force 15 June 2023

The Welsh Ministers, as traffic authority for the relevant length of the A483 trunk road, are satisfied that traffic on specified lengths of the trunk road should be prohibited and/or restricted because of works proposed on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1), (4) and (7) of the Road Traffic Regulation Act 1984⁽¹⁾, make this Order.

Title and commencement

1. The title of this Order is the A483 Trunk Road (Llandovery to Sugar Loaf, Carmarthenshire) (Temporary Traffic Prohibitions & Restrictions) Order 2023 and this Order comes into force on 15 June 2023.

Interpretation

2. In this Order—

“exempted vehicle” (“*cerbyd esempt*”) means:

By virtue of S.I. 1999/672, and section 162 of, and paragraph 30 of Schedule 11 to, the Government of Wales Act 2006 (c. 32), these functions are now exercisable by the Welsh Ministers in relation to Wales.

- (a) any vehicle being used for the purposes described in section 87 of the Road Traffic Regulation Act 1984⁽¹⁾;
- (b) any vehicle being used for naval, military or air force purposes and being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the special forces—
 - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or
 - (ii) for the purpose of training a person in driving vehicles at high speeds;

“special forces” (“*lluoedd arbennig*”) means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director;

“the trunk road” (“*y gefnffordd*”) means the A483 Swansea to Manchester trunk road;

“works period” (“*cyfnod y gwaith*”) means intermittent periods commencing at 00:01 hours on 15 June 2023 and ending when the temporary traffic signs for each period of works are permanently removed.

Prohibitions and restrictions

3. No person may, during the works period, drive any vehicle, other than an exempted vehicle, on the length of the trunk road specified in Schedule 1 to this Order.

4. No person may, during the works period, drive any vehicle at a speed exceeding 40 miles per hour on the length of the trunk road specified in Schedule 2 to this Order.

5. No person may, during the works period, drive any vehicle at a speed exceeding 10 miles per hour on the lengths of the trunk road specified in Schedules 2 and 3 to this Order.

6. No person may, during the works period, use or permit the use of a vehicle, other than an exempted vehicle, in such a way that it overtakes any other vehicle on the lengths of the trunk road specified in

Schedules 2 and 3 to this Order during such times as the restriction specified in article 5 is in operation.

Application

7.—(1) The prohibitions and restrictions in articles 3, 4, 5 and 6 apply only during such times and to such extent as indicated by traffic signs.

(2) No speed limits imposed by this Order apply to an exempted vehicle.

Suspension

8. Any statutory provisions restricting the speed of vehicles on the lengths of the trunk road specified in Schedules 2 and 3 to this Order are suspended during such times as the restrictions specified in articles 4 and 5 are in operation.

Duration of this Order

9. The maximum duration for this Order is 18 months.

SCHEDULE 1

Temporary prohibition of vehicles

The length of the trunk road that extends in a north-easterly direction from its junction with the A40 at Llandovery for approximately 13.8 kilometres.

SCHEDULE 2

Temporary 40 mph or 10 mph speed limits & no overtaking

The length of the trunk road that extends in a north-easterly direction from a point 702 metres north-east of its junction with the A40 at Llandovery for approximately 14.6 kilometres.

SCHEDULE 3

Temporary 10 mph speed limit & no overtaking

The length of the trunk road that extends in a north-easterly direction from its junction with the A40 at Llandovery to a point 702 metres north-east of that junction.
